- **Complimentary WiFi:** SW Texas Telephone provides free WiFi for all vendors. You will receive the password when you arrive.
- **ICE Sales:** Ice will be available for purchase on both Friday and Saturday.

- **Vehicle Removal:** All vehicles must be removed from the park by:
 - **Friday:** 5:00 p.m.
 - **Saturday:** 8:00 a.m.
- **Security:** Security personnel will be present from Friday night through Saturday morning.
- **Booth Operating Hours:** Booths must be open by:
 - **Friday:** 5:00 p.m.
 - **Saturday:** 8:00 a.m. Vendors are required to remain until 4:00 p.m.
- **Departure Guidelines:** No vehicles may exit the park until after 4:00 p.m. (or later if many people remain). You do not need to stay with your booth if you have sold your merchandise or food.
- **Check-In & Overnight Stay:** Vendor check-in begins Friday morning. On Friday, vendors are welcome to stay overnight in the park.
- **Garbage Collection:** Garbage will be collected from your booth at regular intervals. If you require an early pickup before the next scheduled time, please call me to arrange it.
- **Electrical Setup:** Bring any extension cords you may need. There are sufficient electrical outlets available.
- **Beverage Sale Restrictions:** Vendors are **not** permitted to sell carbonated drinks/sodas. Only the Chamber of Commerce booth is authorized to sell these. You may, however, sell water, lemonade, juice, and tea.
- **Noise and Display Standards:** Loud music or displays that do not meet accepted social standards are not allowed.
- **Prohibited Items:** Items such as stink bombs, rubber pellets, drug paraphernalia, or any prohibited symbols may not be displayed or sold.

If you know you cannot attend on August 1 and have an assigned booth, please notify me via phone or email as soon as possible. This enables us to offer the booth opportunity to another vendor, and you will receive a refund.
